# OFAH ZONE "H" report for BPSA Stu Paterson -Oct 2018

1. OFAH is expected to appear before any committee or body studying the issue of a possible Canadian Handgun Ban in wake of a rash of handgun crimes in Toronto. We are taking an active role in fighting for the rights of firearms owners. Our federation has issued this statement about the issue:



One quote from this statement "the firearms community can't understand why the government continues to target them with actions that will have minimal benefits for public safety"

Our Federation continues to be a leader in opposing any such ban which will negatively affect millions of sports shooting Canadian hobbyists. So far there have been no news stories about the fact thousands of illegal hand-guns are smuggled into Canada by First Nations folks at border crossings near Cornwall and Montreal.



2. In a recent commentary, the OFAH President reminded us that some good things happened for the outdoors community under the previous Ontario Liberal government.



Kerry Coleman listed the return of the spring bear hunt as one positive move. However he notes "I never got the impression that angling, hunting and trapping were high on the Liberals' list of priorities." He said they introduced "very few programs that provided direct benefits to anglers, hunters and trappers."

Under the Ford Conservative government Coleman says he expects decisions affecting our outdoors priorities to be based more on science, not emotion as we saw with the Liberals.

Our President reminds us the Mike Harris Conservatives scrapped the spring bear hunt because of pressure from animal rights groups. Kathleen Wynn banned hunting and trapping of wolves and coyotes for the same reasons. In Coleman's words "will all the upcoming changes be positive? Maybe not, but there are some encouraging signs. Let's keep our fingers crossed." President Coleman told me he was encouraged when he heard what the new MNRF Minister said during his August visit to BPSA. Minister Jeff Yurek promised his ministry will improve co-operation and will cut red tape in its dealings with conservation groups.



3. Hunters are being asked to help with a study that will determine the extent of West Nile virus in turkeys and ruffed grouse. It is easy to help. First email study director Dr. Amanda MacDonald at Amacdo21@uguelph.ca. Do this before the fall hunting season. You will be sent envelopes containing submission forms with instructions on how to take part in this study. You will send her your samples which will determine how extensive West Nile is in Ontario's various regions. Easily



recognizable symptoms in game birds include stumbling, head tremors and an inability to fly. The study was launched in partnership with OFAH, Environment and Climate Change Canada and the Canadian Wildlife Health Cooperative.

4. Cormorants continue to have the attention of both the Great Lakes Fishery Commission and OFAH. Will the new Ontario government understand how serious this situation is?

If you don't know what they look like, check out the end of the dock at the Wiarton marina. These hungry birds have had a severe impact on fish populations. One cormorant can eat a pound of fish a day. The commission is calling on governments in the US and Canada to create a long term multi-agency cormorant strategy. For decades OFAH and clubs like ours have been calling for beefed up cormorant controls including removing cormorant protections under the Fish and Wildlife Conservation Act.



5. BILL C-71: A FEDERAL ACT TO AMEND CERTAIN ACTS AND REGULATIONS IN RELATION TO FIREARMS

#### **UPDATE**

The Standing Committee on Public Safety and National Security has finished studying Bill C-71. The OFAH went to Parliament Hill on May



30, 2018 to provide testimony to the committee. The Committee's report on Bill C-71 was presented in the House of Commons on June 12, 2018 and briefly debated (time allocation for debate was restricted). The report recommended only a few amendments, none which addressed the important issues raised by the OFAH during our testimony on the bill. The government's lack of recognition of legitimate concerns of the firearms

community is disappointing, but we are not finished trying to get some significant changes to the proposed legislation.

The fall session is underway and Bill C-71 has received 3<sup>rd</sup> reading. The Bill still needs to make its way through the Senate – a process very similar to what it just went through in the House of Commons. It will be debated, go to committee and be considered for amendments. The process may be similar, but it doesn't have the same degree of partisanship (Senators aren't thinking about re-election, and some are independent). Also, other recent bills (e.g. Bill C-45, the "Cannabis Act") have been scrutinized, hotly debated and subject to numerous proposed amendments in the Senate – some of which were actually accepted by the government in the Commons.

The OFAH will continue advocacy on Parliament Hill to try to get some traction on meaningful changes to Bill C-71.

#### 9. **COMMENTARY:**

I had a chance to talk one-on-one with the Ontario Minister of Natural Resources and Forestry Jeff Yurek when he visited our hatchery this summer. I had discussed BPSA concerns with him for two hours 3 years ago at the annual OFAH conference. At that time he was the MNRF critic for the Ontario Conservative Party. He said he remembered our conversation. During this recent meeting I stressed how important his ministry is to our club and reminded him of our strong desire to have the Ontario Community Hatchery Program (CHP) renewed. The Program is operated by the Ontario Federation of Anglers and Hunters and



funded by the province. It covers more than half of the cost of operating our hatchery.

I was impressed that the Minister chose our hatchery and clubhouse as the site of his first official ministerial visit. I was impressed when he told us "we will be better at consulting with volunteer clubs...we hope to offer better service including streamlining the way we deal with groups such as BPSA". He also said he will transform his ministry to make it more responsive and engaged with conservation groups like ours.

We have thanked MPP Bill Walker for helping organize this ministerial visit. Walker said after the meeting "this was an opportunity to connect and allow Minister Yurek to see first-hand how important recreational fishing is in our area, especially the positive economic impact" it has on our region.

As our President Jim Martell said "all this was refreshing and encouraging for our club".



My bottom line is that perhaps we are in a new era of co-operation and positivity that will benefit our ongoing conservation work.
